A. Matt Lowry shared the following:

### **2. State Championships Refunds**

A. Matt Lowry explained some financial data regarding the cancelled SCMGA State Championships:

- 1) SCMGA has a cash flow challenge currently due to several factors:
  - a) Recent purchase of a new updated Proscore system
  - b) Payment of 260 Program Books for State Week 1
  - c) Partial Costs of Gymnastic Equipment Set up at State Week 1
  - d) Awards purchase for State Week 1 and Week 2
  - e) Deposit on Facility for State Week 1
- 2) The items mentioned above had all been paid prior to the competitions being cancelled. These costs were calculated carefully in making a decision on the amount of refunds that could be given to the athletes.
